

Quantify the Demand

- 2015 University of Wisconsin-Extension Study
- 2015 Northland College Asset & Amenities Study
- 2016 Ashland SOAR event
- Local economic development group and workforce groups had been trying to find a solution
- Infant care nearly impossible to find = workforce issue
- Aging workers and impending retirements in the industry



Hear the Demand

"[F]inding PAID CHILDCARE FOR INFANTS WAS ACTUALLY IMPOSSIBLE... Our youngest children were on wait lists for over a year (and we signed them up before they were born). At one point we were 27th on the waitlist at an infant daycare center. In my experience, the acutest need in Ashland is for infant day care." - Respondent to AADC & Ashland County UW-Extension Survey (June 2015)

Washburn Early Learning Center 65 children on waitlist (March 2018)



EverGrow Learning Center Survey 73 responses indicated a need for care for 80 children

WE ARE IN BUSINESS!... SORTA?



- Center opened November of 2019 with enrollment at 79%
- COVID-19 hit in March 2020
- Enrollment fell to 16% in April 2020
- Summer care and after school care was <u>CRITICAL</u> in 2020
- Summer 2021 classrooms closed temporarily due to workforce shortage

WHERE WE ARE TODAY

- Enrollment at 86%
- Demand for infant care
- Wisconsin Shares use increasing, but many counties still have no families utilizing
- Planned expansion for additional infant care
- Classrooms have re-opened that closed in early fall

CHALLENGES...

- Workforce shortage
- Loss of workers to school systems
- Perception of early childhood education
- No coordinated K-12 programming in rural areas
- Innovative solutions!
